Giving Back To the Industry

Once again, the MHCA will be making a donation to the scholarship fund at the Dunwoody College of Technology. At least one additional scholarship will be offered to a student attending one of the other trade/technical programs in the area.

In addition, the MHCA agreed to provide a contribution to the Joseph Groh Foundation. The Foundation is named after Joseph Groh, who for more than 35 years served in various capacities in the HVAC industry. Joe was paralyzed in a biking accident and his Foundation provides support for those with spinal cord injuries, to support the hiring of the disabled, and to assist families in the industry who have suffered a life-altering injury.

Winter & Spring Seminars Receive High Marks

On February 12, MHCA presented the Honeywell 2.0 Program at Auer Steel in Plymouth. The program was presented to two sold-out classes, one in the morning and one in the afternoon. Participants learned about sequence of operation, troubleshooting techniques, diagnosing problems, and applying universal replacement controls. The session was approved for NATE credit.

Feedback from the program was very positive, with 3/4 participants rating the program as

"Excellent" and the others rating it as "Good." Comments included: "Good mix of training styles," and "Time well spent."

Many thanks to Auer Steel for sponsoring the training facility and lunch.

On April 29, MHCA presented Air Conditioning Service Diagnostics at Gustave A. Larson in Plymouth. The instructor of the program was Michael Prokup, from La Salle, Illinois. Feedback from this program was also very positive, with



one participant saying, "This is the best training program I've been to." Prokup will return September 23rd for a Gas Furnace System Diagnostics Program at the Golden Valley Country Club.

NATE Changes Certification Program

In an effort to improve services to the industry, NATE sought out the input of technicians and industry stakeholders and, based on that feedback, made changes to the certification period, continuing education hours (CEH) requirements, and costs.

The following changes are in effect now:

- •Certification will be on a two-year cycle instead of a five-year cycle.
- •Renewal will require 8 continuing education hours each year (16 over the 2-year cycle).
- •Renewal will cost \$25 for the two-year cycle (plus \$5 for each additional certification).
- •The grace period to document continuing education hours will be 120 days from expiration.

NATE is expected to provide additional information and will announce additional benefits to add value to its certification program, including updated exams, updates to the NATE and HVACRAdvice.com websites, and a new Career Center.

Regional Standards Settlement Approved by Court

The US District Court of Appeals approved a settlement in the long-running Regional Efficiency Standards lawsuit. The settlement follows more than two years of litigation. As part of the settlement:

DOE will now begin the process for developing an enforcement scheme for the regional standard via a negotiated rulemaking process as well as conducting an evaluation to the regulatory process which led to the lawsuit, both terms of the settlement.

A question that has been regularly asked in regards to the settlement is the status of the nationwide heat pump standard. The national heat pump efficiency standard will move to 14 SEER and 8.2 HSPF for split-system heat pumps; 14 SEER and 8.0 HSPF for single-package heat pumps on January 1, 2015. However, because heat pumps have a single national standard, the sell-through period will not be limited to 18-months, as it is for central and single-package air conditioners.
